### Award Categories Include:

#### Citizen of the Year

Awarded to a Colleyville resident who has performed outstanding service or made exceptional voluntary contributions to the community. This service can include involvement in the Chamber and other civic organizations, leadership in business or other accomplishments that have advanced the quality of life in the Colleyville area. *Nominee may be a non-member of the Colleyville Area Chamber of Commerce.* 

### Leadership Award

An individual or group who has consistently demonstrated outstanding leadership in our greater Colleyville area. Leadership encompasses many qualities including vision, integrity, valued direction, encouragement of individuals and positive accomplishments. *Nominee may be a non-member of the Colleyville Area Chamber of Commerce.* 

## □ Youth of the Year

Awarded to a student in the GCISD or a Colleyville resident who attends private school in ninth through twelfth grade for their commitment to volunteerism. Nominations are reviewed and judged based on the youth's demonstrated commitment to volunteerism through action and achievement. *Nominee may be a non-member of the Colleyville Area Chamber of Commerce.* 

## ☐ GCISD Employee of the Year

Awarded to an outstanding Grapevine-Colleyville ISD employee. This individual portrays qualities of commitment, loyalty, vision, dependability and selflessness and is a role model for our youth.

## Business of the Year

Nominee must be an active business and in good standing with the Colleyville Area Chamber of Commerce. Awarded to a business that demonstrates excellence in their professional service industry, provides exemplary customer service, volunteers and provides economic support of the Colleyville Area business community. Has positive social and/or economic impact in the community. *Nominee must be in good standing with the Colleyville Area Chamber of Commerce*.

### Member of the Year

Exhibits outstanding and continuing commitment to the Colleyville Area Chamber of Commerce through selfless involvement in Chamber programs, volunteerism and passion to help the Chamber members succeed. Nominee must be in good standing with the Colleyville Area Chamber of Commerce.

#### □ Jack Oswald Ambassador of the Year
